## Bias and judgement

As mediators, we are supposed to be objective and neutral, but are we always? None of us are 100% free of judgments and biases. Take a minute before your mediation and try to be more conscious of your own reactions and triggers. Having a bias is not bad, but we need to acknowledge it to ourselves so we can be more impartial. Class, sexuality, gender identity, national origin, marital status and physical attractiveness are additional factors that may lead to different types of biases. The key is to acknowledge to yourself that the bias exists and learn ways to manage them to remain effective with the parties.
